Dear Authors,

When submitting your article, please note the following guidelines. Our editorial team can be reached at info@kriminologie.de and will answer any queries you may have.

What you need to send to us

- ✓ **Anonymised manuscript** (that does not contain the name of the author(s) or any information that could be used to identify them) as a **Word file**
- ✓ Article title together with the name(s) of the author(s) and their institution(s) contained in a separate document
- ✓ **Article summary (abstract)**, max. 150 words
- ✓ Four to eight keywords listed in alphabetical order
- ✓ **English** (or, if the article is written in English, **German**) **translation** of the article title, keywords and abstract
- ✓ **Figures, diagrams and charts submitted as separate files** in their original format

Basic formatting

- Font: Georgia (size 11)
- Alignment: justified (body text), aligned left (headings)
- **Structure:** max. three heading levels (1., 1.1, 1.1.1)
- Emphasis in running text: italics
- Please avoid:
 - using the tab key or repeat spaces to position text
 - manual hyphenation
 - links to other sections within the manuscript (cross-references, table of contents, hyperlinks)

Tables, diagrams and figures

- Save **diagrams**, **charts and figures** in their **original format** and as a separate file (they should not be inserted into the text file)
- Scanned diagrams, charts and figures cannot be used; please recreate them instead
- **Tables** should be inserted directly into the text; Georgia (size 10), text should be left aligned, numbers right aligned
- Always reference tables and figures explicitly within the text, e.g. '(see Fig. 3)'. Do not use references such as '(see above)'
- Sentences appearing before a table, figure, etc., should end with a full stop

Numbers, currencies and percentages

- Numbers up to and including twelve are written out in full
- Do not use currency abbreviations in the text body (i.e. 30 euros and not EUR 30 or €30)
- A non-breaking space should be inserted between a number and any corresponding words or abbreviations (in particular between 'p./pp.' and the page number(s))

Abbreviations

Use abbreviations consistently and never at the start of a sentence

Copyright

- Citations, charts and figures are subject to copyright. The author is responsible for securing all the necessary rights
- Use of photos: as a rule, it is necessary to obtain the written consent of any person who appears in an image

Proofreading

- Check spelling in accordance with the Oxford English Dictionary, ensure consistency and please use gender-neutral language
- English Articles have been proof-read by a translator and/or native speaker regarding spelling and grammar

Citations

Please adhere to **APA style (7th edition)**, in particular:

- **In-text citations**: footnotes should not be used. Instead, the surname of the author and the year should be included in the text in parentheses, e.g.: 'Meier (2020) writes that...'; (Meier, 2020)
 - **Multiple publications** by one author from the same year should be listed alphabetically and distinguished through the addition of lower-case letters: (Meier, 2020a, 2020b)
 - If a cited work has **two authors**, their names are separated by 'and' or an ampersand in parentheses, e.g.: (Meier & Müller, 2020)
 - If a cited work has **three or more authors**, the first name should be followed solely by 'et al.', e.g.: (Meier et al., 2020)
 - When citing **multiple sources**, these are to be separated by a semicolon: (Meier, 2020; Weber, 1998)
- When citing **classical works**, the publication year of the first edition is given first, e.g.: (Hegel, 1807/1982, p. 48)
- Direct quotations include the page number: (Meier, 2020, p. 12)
- If there is **no page number** or **year**, 'n.p.' (no page) or 'n.d' (no date) should be included
- **Omissions** in direct citations should be indicated by ([...])
- Direct quotations **longer than three lines** should use size 10 font and italics and be separated from the body text by an empty line above and below the quotation

• **For in-text legal citations**, give the popular or official name of the Act (if any) and the year, e.g. Mental Health Act 1983. Non-English legal texts should be cited in a similar fashion but with the addition of a footnote stating the exact part of the legislation being referenced, e.g. '§ 2 (2) 2nd sentence 2nd alt JGG', upon its first mention in the text

Bibliography

- Please adhere to APA style (7th edition) and
- Font size 10
- Please note the following examples:
 - Monographs:

Author's surname, initial(s) first name(s). (Year of publication). *Complete title* (edition and any revisions). Publisher. e.g.: Meier, R. (2020), *Correct Citation* (3rd ed.). Routledge.

- **Multiple authors** should be separated by commas; an ampersand should appear before the final author's name e.g.: Meier, R., Weber, H., Müller, S., & Yilmaz, M. (2020). *Correct Citation* (3rd ed.). Routledge.
- Edited works:

Editor's surname, initial(s) first name(s) (Ed.). (Year of publication). *Title of the collected volume* (edition). Publisher.

• Articles/chapters in edited works:

Author. (Year of publication). Title of the article appearing in the edited work. In [Editor's first initial(s), surname] (Ed.), *Title of the collected volume* (edition, pages). Publisher.

Journal articles:

Author. (Year of publication). Article title. *Full title of the journal, volume*(issue), pages. DOI or URL

• Electronic publications:

Author. (Year, month day). *Article title*. Website name. Date accessed (if publication date is unknown), URL
